Municipal Ordinance No. 2014-014

THE PROFESSIONALS REGISTRY OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Sec. 447 of the Local Government Code of 1991 (RA7160) states that the Sangguniang Bayan, as a legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of RA 7160 and in the proper exercise of the corporate power of the municipality as provided for under Section 22 of this Code;

WHEREAS, the Local Government Code of 1991 recognizes the vital role of the private sector in local development being a partner in the promotion of the general welfare of the people;

WHEREAS, it is believed that a strong public and private partnership will be a potent force to realize the vision of making Tigbauan a first class municipality;

NOW THEREFORE, **BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN, PROVINCE OF ILOILO THAT:**

SECTION 1. TITLE. This ordinance shall be known as, "THE PROFESSIONALS REGISTRY OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO".

SECTION 2. PURPOSES. This ordinance generally aims to formulate a professionals' registry which will serve as document that embodies a record of Tigbaueño professionals.

Consistent with the goal to maximize public-private partnership, this ordinance aims:

- a. To keep track of the professional growth of the populace.
- b. To properly institutionalize public-private partnership in the affairs of the LGU.
- c. To mobilize the professionals sector of Tigbauan to take an active part in the planning, implementation and sustainability of projects, programs and activities of the LGU that are geared towards the general welfare of Tigbaueños.

SECTION 3. SCOPE. This ordinance shall be applicable to all constituents of the municipality.

SECTION 4. DEFINITION OF TERMS

- a. **Professionals** – any person who acquired a Bachelor’s Degree or any 4-year course.
- b. **Professionals Registry (Registry)** – a document or a book containing a record of all professionals in the municipality either working locally or abroad.
- c. **Professionals Board of Tigbauan** – refers to a non-profit, professionals group whose members come from government and private sectors in the local community which will serve as the consultative body/ partner of the LGU.
- d. **Professional Card** - a card containing the profession of a person and such other information as may be necessary which is duly noted and signed by the Municipal Mayor.

SECTION 5. ROLE OF THE BARANGAYS. All 52 barangays of the Municipality of Tigbauan through their respective Barangay Councils particularly the Committee Chairperson of the Committee on Education are enjoined to provide support for this program, particularly in the gathering and updating of the Registry.

The Barangay shall also make the updating of the Registry *which will be done within the first quarter of every year*. For this purpose, a special committee called the Barangay Professionals Registry Committee shall be formed in every barangay and a copy of Resolution Organizing the same shall be furnished to the Office of the Sangguniang Bayan within 10 days from the constitution of the said committee.

SECTION 6. BARANGAY PROFESSIONALS REGISTRY COMMITTEE. There shall be a special committee for every Barangay composed of the Punong Barangay as Chairperson, Chairperson of the Committee on Education as Vice Chairperson, all Kagawads as members, a member from the youth sector and a member from the professional sector to be appointed by the Punong Barangay from a list of professionals recommended by the Barangay Council.

SECTION 7. METHODOLOGY – the Barangay through its Professionals Registry Committee shall take the lead in gathering the needed data to complete the Professionals Registry of the barangay. The record shall contain the following information, among others which the respective committee’s may deem proper:

1. Name of the Professional
2. Address
3. Profession
4. Specialization, if there is any
5. Date/ Year of passing the corresponding Bar/Licensure examination
6. School attended
7. Office Address, if there is any
8. Contact Details (Phone/email address)

SECTION 8. COORDINATION WITH CIVIL, NON-GOVERNMENT ORGANIZATIONS, SCHOOLS, PRIVATE AND GOVERNMENT INSTITUTIONS, ASSOCIATIONS AND GROUPS. For purposes of a comprehensive professionals registry, coordination and linkages shall likewise be established with the various civic, non-government organizations, schools, private and government institutions, associations and groups in the municipality.

SECTION 9. PROFESSIONALS BOARD OF TIGBAUAN. A Professionals Board shall hereinafter be established in the Municipality of Tigbauan, through an Executive Order to be issued by the Municipal Mayor, with the following composition:

Chairperson	-	Municipal Mayor
Vice Chairpersons	-	S.B. Committee on Education S.B. Committee on NGOs
Members	-	President, Professional Organization of Tigbauan - 52 Barangay Chairperson, Committee on Education - DepEd representatives (one per school) - The Community Affairs Officer - The Information Officer - The Human Resource Officer

SECTION 10. ROLE OF PROFESSIONALS BOARD OF TIGBAUAN:

1. To lead in the compilation and completion of Registry;
2. To update the Registry Program *annually*;

3. To plan programs, projects and activities that will maximize the partnership of the LGU with the professional sector of Tigbauan;
4. The Board may be called upon by the Municipal Mayor to make recommendations on certain programs, projects or activities of the LGU.

SECTION 11. MEETINGS OF BOARD The Board shall meet regularly twice a year and as frequent as the need arises upon the call of the Chairperson or majority of its members upon proper notice within 24 hours from the time and date of the special meeting.

SECTION 12. HANDLING OF REGISTRY. The registry is considered a vital document and its custody and care shall be the responsibility of the Office of the Municipal Mayor and the Office of the Sangguniang Bayan.

SECTION 13. PROFESSIONAL'S CARD. To serve as local identification/ membership card, every professional, upon payment of professionals tax receipt (PTR) with the LGU shall also be issued a professional's card duly signed by the Local Chief Executive. A reasonable cost for the printing and/or lamination of the said card will be charged from the professional concerned, the Professionals Board of Tigbauan is hereby authorized to formulate the administrative rules and regulation for the issuance of the Professional's Card.

SECTION 14. FUNDING. An initial amount of Php. 30,000.00 shall be appropriated in the general fund to ensure the viability and continuity of the various activities related to the program chargeable against the Gender and Development (GAD) fund. Furthermore each Barangay shall appropriate a certain amount in their respective budget as deemed needed which will serve as their counterpart to ensure sustainability of the program, also to be included as part of their GAD programs, projects and activities.

SECTION 15. SEPARABILITY CLAUSE. In case any provision of this ordinance is later declared unconstitutional, the other provisions not affected shall remain in full force and effect.

SECTION 16. REPEALING. All previous ordinances, executive orders, rules and regulations or parts thereof which are inconsistent or in conflict with this ordinance are hereby repealed or modified accordingly.

SECTION 17. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
